1. The sealed envelope containing the quotation must be super scribed "**Quotation for Repair of Signage logo and Apparel House**" and can be submitted either by post or through Courier or by hand addressed to **Joint Director(AHM), Apparel Export Promotion Council, Apparel House, Sector-44, Institutional Area, Gurgaon, Haryana-122003** on or before **10th August, 2018**. The agency may satisfy and visit the site to assess the type and volume of work before submitting the quotations **and Council will not be responsible after issue of award letter.**

2. General scope of work:

The selected agency/firm shall be responsible to repair and fix the Signage Logo and Apparel House in the office premises at Apparel House, Institutional Area, Sector 44, Gurgaon-122003, Haryana during **working Days/hours** of the Council. The sample of Signage logo and Apparel House is attached (**Annexure-I and II**).

3. Terms and conditions:

- i) The Agency/Firm should have sufficient experience and trained workers and be in existence for over 5 years.
- ii) The Agency/Firm should have Pan Number, GST/sales tax/VAT registration number.
- iii) The quoted rates should be in respect of genuine items and should be exclusive of Taxes.
- iv) The contract as a whole or part thereof is **non-transferable**.
- v) Only one Quotation should be submitted duly signed by proprietor/authorized person.
- vi) AEPC reserves the right to reject any or all the quotations without assigning any reason.
- vii) Quotation received after due date, without sealed cover and incomplete will not be accepted.
- viii) Bid document can be downloaded from the AEPC's website www.aepcindia.com.
- ix) Minimum validity of bid should be 45 days.
- x) The Agency/Firm shall provide all tools, tackles, support, scaffolding, manpower etc. No additional payment or escalation of any sort shall be entertained.
- xi) The agency shall be responsible for the warranty of the work executed. Any defects noticed within a period of six months shall be rectified immediately and at no additional cost to the Council

4. Terms of Payment:

No advance payment in any case shall be made. Payment shall be made after repair of all signage of the council as per award letter, specification, rates as well as satisfaction of the AEPC and on submission of original bill indicating payable tax. The agency/firm shall be bound to repair and fix **Signage logo and Apparel House** as per rates quoted in the bid only and within the prescribed period.

5. Arbitration:

In the event of any dispute or difference arising under the contract agreement, the same shall be referred to the sole arbitration of Secretary General, AEPC or anyone appointed by her. The award of the arbitrator shall be final and binding on both the parties. The venue of arbitration proceeding shall be at AEPC Head Office, Gurgaon, Haryana.
