Sub: AEPC's participation in International Apparel & Textile Fair on 14-15 November, 2016 at Dubai

Dear Members,

(1) Apparel Export Promotion Council is participating in International Apparel & Textile Fair scheduled from 14-15 November, 2016 at **Dubai**. UAE is one of the top destination of apparel exports from India, the statistics of UAE's import from world and India's exports are given below which depicts that there is a huge market for Indian Apparels in UAE.

Participation charges after 30th September, 2016	:Rs. 1,60,000/-

No part payment will be accepted.

This does not include Airfare, Hotel expenditure etc.

Since, there is no MDA/MAI support for this event; the Council is offering a highly subsidized price of Rs. 1.60 lacs from the original price of the Fair authority of Rs. 2.41 lacs (USD 3600).

You are requested to kindly send the participation fee by way of **Demand Draft/Pay order** in favour of "**APPAREL EXPORT PROMOTION COUNCIL**" as per the above details to Ms Sneh Lata Sharma, Jt. Guidelines for the Allotment of booths:

1. All the participants who pay the full participation fee in time would be considered for allotment of booths through draw of lot and **allotment would considered only on FCFS basis.**
2. The decision of SG, AEPC /Chairman (EP)/Chairman, AEPC would be final and binding in case of any clarification.
3. For the allotment of booths, where any vacancy arises after the allotment on FCFS basis, the same would be subject to the discretion of the Secretary General/Chairman (EP)/Chairman, AEPC.
4. No change in the booths, once allotted would be entertained under any circumstances.

The participation is on FIRST-CUM-FIRST SERVED (FCFS) till all the booths are sold.

Waitlist :

In case, application are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. No request for refund will be entertained by AEPC if for any reason whatsoever.

Cancellation Charges:

The exporter who will apply for participation in the show, the withdrawal will be subject to the following:

1. 45% of the participation charges will be forfeited if the exporter withdraws after confirmation of participation by the Council and other exporters on wait list confirms their participation. There will be forfeiture of 65% of participation fee if no other exporter is on the wait list.
2. 100% forfeiture in case of no show.
3. Non-grant of relevant visa shall not qualify for any relief.
