TERMS & CONDITIONS FOR NATIONAL FAIR

Firms desirous of participating should apply in writing to HEPC in the prescribed form (attached) together with a D.D. towards participation fee

- 1. Selection of participants will be done as per the following criteria:
 - a. Export turnover and product acceptability.
 - b. Suitability for export
- 2. HEPC reserves the right to reject any application for participation without assigning any reason thereof.
- 3. HEPC will make allocation of available space in the show premises at its discretion and its decision to this regard will be final and binding on all.
- 4. Participant who acquires space through either the Fair organizers or through any other source will not be considered for participation and if it is found that they have indulged in such activities, they will be debarred in future for 3 consecutive years from participating in the events organized by HEPC.
- 5. Participant who acquires space through false information is liable to repay the grant amount and also be debarred in future for 3 consecutive years from participating in the events organized by HEPC
- 6. Participants will make their own arrangements for dispatching the exhibits for display and brining them back to India after display.
- 7. Participants will not be allowed to remove the exhibits during the show without specific written permission from HEPC.
- 8. Participants will adhere to such other regulations as may be prescribed by the Fair Authorities.
- 9. In the unlikely event of postponement/cancellation of the Show, HEPC shall be under no liability to compensate expenditure, if any, incurred by the participants.
- 10. HEPC will not be responsible for any damage or loss of exhibits during transit or during the fair.
- 11. No refund of participation fee will be made by HEPC under any circumstances excepting in case of non participation by HEPC.
- 12. Those who had already participated 3 times in the fair through HEPC are not eligible for the grant in aid under D.C.(HL) / MDA scheme They will be requested to pay full participation fee.
- 13. In the event of violation of the Fair authority Rules by a participant, HEPC/ Fair authorities shall have the right to close down the stall of the participant concerned immediately.
- 14. Participants are also required to furnish information regarding value of business generated through this fair participation during 6moths 0ne year period after fair participation
