Annexure-II

(B). <u>The eligibility criteria and terms/ conditions for grant of awards for the year 2016-17</u> <u>are given below:-</u>

- 1. The base period for considering the awards would be the export performance during F.Y. 2016-17. The scheme of awards is open to those who are member of the Council under the Export Import Policy of the Government of India. The applicant must have paid AEPC subscription for the years 2016-17 and 2017-18.
- 2. Applications for grant of Export Awards will be considered subject to the condition that nothing adverse about the business dealing of the applicant has come to the notice of the Council and/ or other authorities.
- 3. Items of exports for grant of Export Awards include all type of readymade garments (RMGs) falling in HS Code 61 & 62.
- 4. Export performance should include only those exports which have been reflected in the name of the applicant / company.
- 5. Export performance should include the value of only those manufactured products which are exported from Indian soil. The Chartered Accountant's Certificate should clearly specify this.
- 6. For grant of award in each category there should be minimum 3 applications.
- 7. No application for Export Awards would be considered if the application forms are not properly filled-in and incomplete applications are liable to be rejected. Applications received after the due date is also liable to be rejected.
- 8. Each application will be considered for the award in the Categories under the scheme and hence complete details should be given and each column of the application should be filled up. Applicants of category at sl. Nos. 1 to 5 of Highest Global Exports shall not be eligible for grant of awards at serial Nos. 6, 7 & 8 of Highest Exports in Knitted Garments.
- 9. The export figures are to be given by the exporters in terms of FOB value of exports on the actual exports affected during the financial year 2016-17. <u>Only direct exports will be taken into account for the purpose of selection of export awards.</u>
- 10. FOB value of exports should be value of exports excluding commission paid / payable to overseas agents / importers only should be shown. The exporters will have to produce a Chartered Accountant's Certificate certifying that the figures provided by the applicant were verified and found to be corrected by them.
- 11. AEPC will be checking all applicants details from RCMC & Vigilance Department & shall confirm that:
 - a) The payment has been duly received.
 - b) There is no vigilance case against the applicant.
 - c) The export performance mentioned includes 'Direct Exports' only.

- 12. Highest Exports in the category of Young Entrepreneurs 2016-17.
- i) The candidate should be between the age of 18 years and 35 years as on 31.03.2016 and should be proprietor / Director/Partner of the company at least w.e.f 1.4.2016.
- ii) The export turnover of the company should not be less than Rs.50 crores during the financial year 2016-17.
- iii) The criteria for award would be highest value of exports achieved in 2016-17 by applicants who qualify S No (i) & (ii) above respectively.
- 13. For Highest Exports in the category of New Entrepreneur , the company should be established after 31.03.2014 and must be member of AEPC during 2016-17 (between 01.04.16 and 31.03.17)
- 14. For Highest Exports in the category of women Entrepreneur , the company should be established after 31.03.2014 and it should be a proprietor concern must be member with AEPC during 2016-17 (between 01.04.16 and 31.03.17)


