The catalogues shall be well placed for visitors during the show. The dead line for submitting the catalogue shall be 31.05.2017. Each party is restricted to send one copy of their catalogue. #### Waitist

The participations on First-cum-first basis. In case, applications are received beyond 20 nos. a waitlist will be maintained, and their participation would be considered on FCFS basis, if any vacancy arises.

#### **CANCELLATION CHARGES**

#### Withdrawal will be subject to following:

- 1.45% of the participation charges will be forfeited if the exporter withdraws after confirmation of participation by the Council and other exporters on wait list confirms their participation. There will be forfeiture of 65% of participation fee if no other exporter is on the wait list.
- 2.100% forfeiture in case of no show of the fair.
- 3. Non-grant of relevant visa shall not qualify for any relief.
