- 4. The tender form completed in all respect should be sent in a sealed cover and subscribed as "Quotation for supply of LED lightings and fixtures of AEPC" and should be submitted to Director (AHM), Apparel Export Promotion Council, Apparel House, Sector-44, Institutional Area, Gurugram-122003, Haryana latest by <u>5.00 pm on 28th November, 2017.</u>
- 5. The quotations received will be opened in this office in the presence of the senior officers of the Council. The work will be awarded to the firm quoting the lowest rates.

Final decision: The A.E.P.C. has the right to accept any quote in whole or part or reject it entirely without

assigning any reason thereof. Quotations received after due date will be summarily rejected. In case of any disputes whatsoever, the Secretary General AEPC shall be the

sole arbitrator and his decision shall be final and binding.

6. SCOPE OF WORK:

- 1. The technical specifications and the requirement of the LED lights and fixtures at Apparel House is given in **Annexure-I**
- 2. The agency would provide the lighting and fixtures suitable to existing fixtures.
- 3. The work prescribed in the document would be completed in coordination with the AEPC Facility Management Team and AEPC Technical staff.
- 4. The contract as a whole or a part thereof is non-transferable.

7. ELIGIBILITY CRITERIA:

- 1) A registered Firm/Company (under applicable Act) having experience of at least five years in providing LED lights and fixtures to Central Government/State Government Department/Institution, including Public Sector Companies/ Undertaking/Autonomous bodies, Multi National Companies/ Private institutions.
- 2) Conformance to technical specification as mentioned in Annexure-I
- 3) The company should have valid GST Registration, PAN/TAN. A copy of the same shall be furnished along with the tender.
- 4) The firm should have expertise to work in onsite installations of high rise buildings without damaging the existing structure.

8. LIABILITIES:

i) The firm shall be under liability to provide the lights and fixtures as per existing setup. No additional charges would be paid to accommodate any changes in the existing fixture structure.

- Ii) The firm shall be under liability to compensate for any damages for any consequential damages resulting from delay in providing the product or any error during installation.
- iii) The firm shall intimate in advance about the visit of their personnel and the work will be undertaken only during working days of the Council except in case of any emergency work
- iv) The firm shall provide a warranty of minimum 24 months of the product from the date of receipt of the product. All product complaints within the warranty period must be attended free of cost within 24 hours.

9. TERMS AND CONDITIONS:

i)Price: The quoted rates shall be valid for a minimum period of three months. All

applicable charges need to be clearly mentioned in the tender. Rates awarded as per contract will remain fixed for the entire duration and no cost escalation will

be permitted under any circumstances.

ii)Termination of Contract: Apparel Export Promotion Council reserves the right to terminate the contract by

giving 7 days notice without assigning any reason whatsoever.

iii)Payment: Payment shall be made upon receipt, verification and installation of materials and

submission of tax invoice.

iv)Workmen employed: The vendor shall be responsible for all labour laws and statutory requirement,

insurances, medical treatment to any illness, injury in or outside premises etc pertaining to his employees and shall be responsible against any claim on this account. The Council shall not be responsible for any dispute between the firm

and its workers.

v)Certification of bills: All bills to be certified by the authorized officer of employer and rechecked by the

officials of the AEPC before release of payment.

vi)Disqualification: Under no circumstances the respondents are to contact any AEPC employees,

other than the Director (AHM) or authorized by him with regard to this contract or any of the information. Violation of this provision will subject to immediate disqualification and no further communication in this regard will be entertained.

10. ARBITRATION:

Any legal disputes arising out of and in relation to this agreement, Secretary General, AEPC or anyone as appointed by him, shall be the sole arbitrator and his decision shall be final and binding on both the parties. The venue of arbitration shall be Apparel House, Gurugram

11. BID SUBMISSION:

Duly completed bid documents addressed to the undersigned should be submitted before the due date (on or before 06.11.2017 by 5:00 pm) in the manner described as under:-
