**D. GENERAL CONDITIONS /INSTRUCTIONS FOR SUBMISSION OF BID.**

1. Sealed Quotations are invited directly from established agencies/firms (single entity) for CONDUCTING AWARD FUNCTION.
2. The agency should have the Registration no. of GST.
3. The Quotation Document, complete in all respects, to reach on or before the due date and time at designated email id [tender@aepcindia.com](mailto:tender@aepcindia.com)
4. The bid should also be submitted in a sealed envelope and it should be super scribed as **“QUOTATION FOR CONDUCTING EXPORT AWARD FUNCTION ON 9<sup>TH</sup> DECEMBER, 2023 AT NEW DELHI”**. The Technical Bid & Financial Bid should be submitted in separate sealed envelope and both the envelops should be submitted in the main sealed envelope.
5. The last date of receipt of bid in a sealed envelope is on or before 7<sup>th</sup> November, 2023 up to 5.00 pm and should be submitted to Dr. Tamanna Chaturvedi, DSG , Apparel Export Promotion Council, Apparel House, Sector-44 Institutional Area, Gurgaon, Haryana-122003. 6. The refundable Earnest Money Deposit (EMD) of Rs.20,000/- (Rupees Twenty Thousands only) in the form of Demand Draft/Pay order drawn in favour of **“Apparel Export Promotion Council”** payable at **Gurgaon, Haryana** is to be submitted along with the bid. 7. AEPC will award the contract to the successful bidder where bid has been determined to be technically as per parameters mentioned in Annexure I. The vendors who qualify in Technical Bid will be eligible for financial Bid participation and the L1 financial bid will qualify for award of contract.
8. The EMDs of the unsuccessful bidders will be refunded without any interest. The performance guarantee for the successful L1 bidder shall be Rs. 50,000/-. After adjusting the EMD of Rs. 20,000/- additional performance guarantee of Rs. 30,000/- shall be remitted by the L1 bidder to make the total performance guarantee equivalent to Rs. 50,000/-.
9. All the pages/documents of the bid should have signature of the bidder with the stamp of the Firm. Any over-writing, corrections & cuttings should have initials of the bidder. Corrections should be made by writing again instead of shaping or over-writing.

10. Rates should be quoted in Indian Rupees (Rs) in figures. Please ensure to specify about the applicable taxes, if any.
11. Conditional quotations are liable to be rejected.
12. AEPC reserves the right to reject or accept any or all application(s) without assigning any reason(s).
13. AEPC reserves the right to increase or decrease services in Quotation document.
14. The quotation should be valid for a minimum period of up to 31<sup>st</sup> January, 2024.
15. **The terms of payment are as follows:-**
  - **50% of the total contract value on signing of contract and upon conforming bookings of Audio Visual equipments, LED panels etc. required for the show.**
  - **Balance 50 % after conclusion of the show on satisfactory performance and submission of final bill.**

**E. The Performance Guarantee shall be forfeited by the AEPC in following cases:**

- i. The L1 agency withdraws their offer during the period of quotation validity.
  - ii. After opening of Financial Bids, the bidder fails to honor the contract or refuses to comply with any or all terms and conditions of the quotation.
  - iii. If the services of the Agency is not found satisfactory as per the terms & conditions of the quotation.
- F. In case of any dispute or difference arising in relation to meaning or interpretation of the agreement, Chairman, AEPC would be the final arbitrator. The decision of the arbitrator shall be final and binding on both the parties.

The losses to the AEPC if any, which are directly attributable to the agency shall be deducted from the bills.

**G. RIGHTS OF AEPC**

- (i) AEPC reserves the right to accept / reject the offers received, or call for any additional information /clarification/ presentation, or modification/cancellation of the bidding process, if so required, without assigning any reasons whatsoever.
- (ii) AEPC reserves the right to cancel/terminate the agreement at any time without assigning any reason.

1. Confidentiality of any data and information provided by AEPC and other agencies to the Vendor should be maintained.

2. Governing Law and Jurisdiction: This agreement shall be governed by the laws in India and shall be subject to New Delhi jurisdiction.

For the purpose of this proposal "Force Majeure" means an event which is beyond the reasonable control of AEPC and is not foreseeable.
