### AEPC's PARTICIPATION IN "BARCELONA TEXTILE EXPO, BARCELONA, SPAIN - 2026" (From 21 - 23 October, 2026)

Dear Members,

Apparel Export Promotion Council (AEPC) is participating in Barcelona Textile Expo 2026, an International Fashion Sourcing Fair at Fira de Barcelona, Spain, scheduled to be held from 21<sup>st</sup> to 23<sup>rd</sup> October, 2026, offering a comprehensive platform to the Indian apparel manufacturers.

#### 1. About Barcelona Textile Expo 2026:

Barcelona Textile Expo - 2026 is a prestigious event and the largest apparel & textile exhibition in Spain, serving as a vital gateway to the European market, with significant visitor traffic from across the region. This Textile Expo, created in response to market demand, started its journey with the target of becoming the most attractive meeting point in Barcelona.

Over +300 exhibitors from 12 countries like Spain, Germany, Turkey, China, Italy, Korea, Bangladesh, Japan, India, Pakistan, Hong Kong & Uzbekistan etc., and 4800+ professional visitors are going to participate in this show with their models and creations. The main goal of the exhibition is to create, establish and strengthen trade relations between textile/apparel/ accessories/fabric/producer exhibitors and professional buyers. Visiting Textile Expo will be a great opportunity to see new creations and to buy the high quality apparel at the best prices. The main product categories displayed in this show are woven/knitted garments, home textiles, yarn, and accessories.

#### 2. Schedule :

The Barcelona Textile Expo shall take place at Fira de Barcelona, Spain on the following dates :-

Fair Days : 21<sup>st</sup> - 23<sup>rd</sup> October, 2026 (Wednesday - Friday)

Main items of export to Spain are- Men/ Boys/ Women's/ Girls/ Kids Trousers, Breeches & Shorts, Dresses, T-shirts, Singlet's, Jerseys, Jackets, Pullovers, Cardigans, Waist Coats, Blouses, Shirts, Blazers suits Jerseys, Sweatshirts, Sports & swimwear Night & Underwear Caps, socks, gloves, Shawls, Belts, Ties, Anoraks and other Vests, Infant wear Garments and other clothing accessories etc.

#### 4. Participation Charges for exhibitors :

Participation Charges are as mentioned below :

Without MAI/MAS (Market Access Support)	Participation Charges
Cost per booth (size : 9 sqm.)	Rs. 4,50,000 /-
Early Bird Discount ( - ) Rs. 15,000/- If payment is made on or <b>before 15<sup>th</sup> July, 2026</b>	Rs. 4,35,000/-
The participation charges do not cover airfare, hotel expenses, or any other personal costs (such as logistics), including the transportation of display materials and other related expenses, which are the responsibility of the exhibitor.	
The applicants, who fail to make full payment of participation charges, will not be considered for allotment of booth.	

5. The deadline for submitting the application along with payment is 30<sup>th</sup> July, 2026 (Thursday).
6. Financial Assistance under the Market Access Support (MAS) Schemes under Export Promotion Mission (EPM) of the Central Government :
- 6.1 All members who wish to avail financial assistance under the Export Promotion Mission (EPM) are advised to carefully review and promptly fulfill the eligibility requirements prescribed under the Market Access Support (MAS) Schemes of the Central Government. These requirements are outlined in the official guidelines issued by the Government and are available on <https://www.trade.gov.in/pages/Market-access-Support> and is currently available on the link (<https://content.trade.gov.in/EPM-Scheme-Guidelines/Guidelines-for-Support-for-Market-Access-under-the-Export-Promotion-Mission.pdf> ). Members are further informed that non-compliance with these requirements may result in rejection of claims.
- 6.2 These guidelines are subject to revision and will be updated from time to time. Members are advised to remain apprised of the same and take necessary action accordingly in a timely manner. Members are advised to keep themselves updated in this regard by visiting <https://www.trade.gov.in/>
- 6.3 The Apparel Export Promotion Council has submitted the proposal to the concerned Ministry seeking grants under the Market Access Scheme (MAS) of the Export Promotion Mission (EPM) for participation in the above-mentioned event. The Ministry's decision on the proposal is currently awaited, and no grant shall be deemed sanctioned or approved unless and until formal written confirmation is received.
- 6.4 Upon receipt of the MAI/MAS grant from the Ministry, the booth cost will be subsidized and the balance amount will be refunded to the eligible exporters accordingly.
- 6.5 The number of exhibitors eligible to receive financial assistance under the schemes framed under the Export Promotion Mission (EPM) shall be determined by the Government of India through the concerned Ministry(ies). Financial assistance will accordingly be extended only to the number of exhibitors as approved by the Ministry. In the event that the number of exhibitors approved for financial assistance is fewer than the number of exhibitors who actually participated in the event, assistance from the Government shall be granted strictly on a first-come first-served basis. Members are therefore advised to submit their applications promptly and in full conformity with these

provisions, keeping in view that assistance will be limited to the extent sanctioned.

### NOTE:

- a) **No cheque payment will be accepted.**
- b) **Please ensure to share the UTR Details in case of online payment, failing which your participation would not be considered even if payment is already made.**

## 8. Booth Packages: The following booth facilities shall be provided to the participating exhibitors.

Wooden display booths (9 sqm), electrical connection 220V, 1 table, 3 chairs, 3 spotlights, 1 m pipe hanger with 2 rows or 3 m single shelf in a row.

**Note: Additional displays, advertising, branding, modified fascia, hangers, additional electrical installation and other services can be provided at additional cost.**

## 9. Guidelines for allotment of the booths:

- i. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot by AEPC.
- ii. No change in the booths, once allotted would be entertained under any circumstances.
- iii. The decision of Chairman-EP (AEPC) / Chairman (AEPC) would be final and binding in case of any dispute.
- iv. The participation is on FIRST-CUM-FIRST SERVED (FCFS) till all booths are sold and the allotment of stalls shall be done through draw of lot basis.

## 10. Waitlist:

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess will obtain necessary visa to enter Spain. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

## 11. Withdrawal/ Cancellation Terms & Conditions :

Terms & conditions for withdrawal / Cancellation of participation will be as follows:

- Rs.25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.

- 100% forfeiture after Draw of Lot.
