Apparel Export Promotion Council (AEPC) is participating in Saudi Fashion & Tex to be held from 25<sup>th</sup> to 28<sup>th</sup> September, 2025, which will take place at Jeddah International & Convention Center, Jeddah, Saudi Arabia.

1. About SAUDI FASHION & TEX - The event is Saudi Arabia's biggest Fashion & Textile Show and is dedicated to the latest innovations, trends and advancements in apparel & fashion, textiles and leather products and this show provides an unparalleled platform to connect with key industry players, potential buyers and global fashion leaders.

3rd (edition) Saudi Fashion Tex – Saudi International Fashion, Textiles & Leather Exhibition will open its doors in Jeddah International Exhibition & Convention Center with the participation of leading garment exhibitors and brands from the most prestigious fashion and textile producers of the region. This platform allows national and international companies of different industry sectors with the support of the **Riyadh Chamber of Commerce**, to show and promote their skills, meet partners and venture into a new and thriving market. The previous event featured 337 exhibitors and attracted 12,420 buyers. This year, approximately 500 exhibitors are being planned to participate.

Saudi Fashion & Tex Fair will feature thousands of latest trends and textile products by gathering fashion specialists and textile buyers from the Gulf and African countries. Saudi Fashion & Tex Fair is Saudi Arabia premier platform for sourcing Women's Wear, Men's Wear, Kid's Wear, Sports Wear, Knitwear, Socks, Garments, Lingerie, Leather Wear, Shoes & Bags Accessories etc. Exhibitors are mainly from Saudi Arabia regions, Turkiye, Egypt, Italy, USA, Hong Kong, Japan, India, Jordan, Morocco, China, Pakistan, U.K., Indonesia, Bangladesh, Spain, UAE, Sri Lanka, The Netherlands & many more highly

renowned manufacturing countries across the globe. Saudi Arabia's fashion industry is rapidly expanding, with increasing demand for quality apparel & textiles, sustainable fashion and innovative designs.

RMG imports into Saudi Arabia have increased in the last five years. Saudi Arabia's import from India has also increased in these past years. Import from India's in 2020 was 462.9 USD mn., which increased to 550.5 USD mn. in 2024. India has captured a share of 13.4% in 2024. At a category level according to 2024, Woven RMG holds a much better acceptance in Saudi Arabia as compared to knitted apparel.

## 5. Eligibility for financial assistance under Market Access Initiative (MAI) scheme:

The Apparel Export Promotion Council has submitted a proposal to the concerned Ministry, requesting the MAI Grant for participation in the Saudi Fashion & Tex Fair. The Ministry's decision on our proposal is awaited and cannot be considered approved unless confirmed in writing.

## The MAI Grants as and when received will be disbursed to the eligible exhibitors as per MAI Norms.

It is pertinent to mention that as per Notification no. K-11020/9/2021-E&MDA dated 19<sup>th</sup> July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for availing MAI grant with following conditions:

"a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be provided to a member for a maximum of three MAI events in a year. In case of exporter belonging to SC/ST/Women and the exporter is having FOB Value of exports less than Rs. 50 crore in a year, 5 participations in a particular event is allowed."

**Reimbursement of airfare: -** Further, the Council would propose to Dept. of Commerce for sanction of grant on account of reimbursement of airfare (economy class) if it is approved by Ministry of Commerce, Govt. of India.

Accordingly, regular Director / Partner / Proprietor / regular officer of the company on senior managerial position of participating firm/company having 12 months membership with Council, exporter having minimum FOB value of exports Rs. 50 Lakhs but below Rs. 50 Cr. in the preceding financial year shall be eligible for reimbursement of airfare as per MAI Guidelines under para 6 (ii) of the Market Access Initiative Scheme 2021 issued by the Ministry of Commerce from time to time. **Non-MAI Exhibitor shall not be eligible for reimbursement.** 

(On receipt of MAI grant from the Ministry, the booth cost will be subsidized and the balance amount would be refunded to the eligible exporters as per MAI norms)

6. The deadline for submitting the application along with payment is 10<sup>th</sup> June, 2025.

- **8. Booth Packages:** The booth package includes Stand construction, Wall elements, Carpet, Spotlights, Table and chairs, Hang rails or shelves and Triple socket.

#### 9. Guidelines for allotment of the booths:

- i. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot by AEPC.
- ii. No change in the booths, once allotted would be entertained under any circumstances.
- iii. The decision of Chairman-EP (AEPC) / Chairman (AEPC) would be final and binding in case of any dispute.
- iv. The participation is on **FIRST-CUM-FIRST SERVED (FCFS)** till all booths are sold and the allotment of stalls shall be done through draw of lot basis.

#### 10. Waitlist:

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess will obtain necessary visa to enter Saudi Arabia. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

# 11. Cancellation charges: Terms & conditions for withdrawal will be as follows:

- Rs. 25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.
- 100% forfeiture after Draw of Lot.
