SPECIFICATIONS AND QUANTITIES OF THE REQUIRED EQUIPMENTS FOR AUDITORIUM

1. CARPET

- a) Loop pile carpet having thickness of 8mm thickness and gauge of 1/10. The Pile weight should be minimum of 600gm/sqm.
- b) Carpet tiles are not allowed
- c) Standard width of the Carpet roll shall not be less than 2 mtrs.
- d) The yarn material shall be able to withstand rugged usage and shall be abrasion and flame resistant and should pass the methenamine pill test. Should have acoustic properties.

2. AUDITORIUM/THEATRE/CINEMA CHAIRS

- a) Push back with auto slider and tip up mechanism
- b) MS Frame with powder coated finish
- c) Ergonomically designed back with molded foam cushioning and fabric covering upholstery.
- d) PU top armrest with cup holder and slot for numbering
