2. Minimum eligibility Criteria (copy of the documents to be attached):

- Self-attested copy of Certificate of incorporation /Registration of firm / Partnership deed /Proprietorship Deed.
- Copy of GST registration.
- Statement on company letter head certifying that the firm has not been blacklisted by any government agency.

3. Scope of work:

- 3.1 All equipment offered for disposal is on "AS-IS-WHERE-IS" basis, as Ex-Godown in unpacked condition. All Capital Goods are those with Style no longer current, indistinct or are imperfect as compared with corresponding part in the related industry.
- 3.2 The material has to be lifted within 10 days after making of full and final payment by the highest

successful bidder.

- 3.3 The materials will be allowed to be lifted between 10:00am to 5.00pm on any working days. No picking, choosing or sorting will be allowed in the premises for the disposal lots.
- 3.4 Mis-description or error in quantity will not invalidate a sale. The bidders are advised to check the materials, quantity and description physically at site before bidding.
- 3.5 Labour, transport and other arrangements will have to be made by the purchaser at their risk, cost and responsibility. AEPC will not be held responsible for any loss/accident at the site, of manpower deployed by the bidder. Also in case of any damage occurring in the building/infrastructure during lifting of material, the contractor will have to make good the same before leaving the site.
- 3.6 The material will be disposed-off in a single lot and the bidders will have to submit price for complete lot.
- 3.7 The person authorized by the purchaser will be allowed to take delivery.
- 3.8 No items, once disposed to the successful bidder, shall be taken back by office.
- 3.9 Declaration letter to be submitted by the successful bidder that the equipment/material shall either be disposed off in a safe manner abiding by all applicable rules and guidelines or shall be used only for lawfully accepted activities. The successful bidder shall indemnify the Council of any misuse/improper disposal of the equipment/machinery being done after the equipment/material leaves the AEPC designated premises.

4. **Security Deposit:**

- (a) The Security Deposit equivalent to 10% of the bid amount shall be transferred electronically through RTGS/NEFT as per Bank details given below:

- (b) It may be noted that any Quotation without Security Deposit is liable to be rejected at the discretion of AEPC.
 - (c) The Security Deposit of the unsuccessful bidders will be refunded by way of RTGS/NEFT without any interest within 30 days of award to the successful bidder.
 - (d) The Security Deposit of the successful bidder shall be returned upon receipt of requisite disposal amount
5. **Bid validity:** The prices quoted shall remain valid for 45 days from the date of opening of bid and in respect of accepted bid the prices quoted shall remain valid for 90 days.
6. **Bid Opening:** The bid/quotes received will be opened in this office in the presence of the senior officers of the Council. Bidders who wish to attend the opening of the bids may ensure their presence on the mentioned date and time as specified in the Date sheet.

7. Evaluation of the bids:

- a. The bidders are free to quote for disposal of goods partially or wholly. However, bidders who quote wholly would be given preference.
- b. Bids without security deposit or security deposit less than 10% of the bid amount shall be liable for rejection
- c. The highest bidder shall be considered as the successful bidder.

8. Safety, Security and protection for the environment: The bidder throughout the execution and completion of the works and remedying of any defects therein have full regard for the safety of the persons entitled to be on the site and keep the site in an orderly state appropriate to the avoidance of danger to such persons, provide and maintain at his own cost all necessary requirements and watching them where necessary required, take all reasonable steps to protect the environment on and off the site and to avoid damage to persons or to the property of the council or others resulting from noise or other causes arising as a consequence of his methods or repair.

9. Delay in lifting/clearing of materials: The successful bidder shall have to lift the materials within the time specified. In case, the materials are not lifted without any plausible explanation/reason, the materials not removed thereafter will be treated as abandoned lots and the security deposit and other sums paid for the lot will be forfeited without any reference to the purchaser. For such abandoned lots, the Council reserves the right to re-sell.

10. Time for Completion: The work shall be completed within a period of Ten (10) days and shall start from the date of receipt of payment after issue of the Work Award/Sale Release Letter and shall stand terminated after the expiry of the said period.

11. Terms of payment:

- a) 10% of the bid amount shall be submitted as Security Deposit along with the bid
- b) Balance 90% of the bid amount shall be submitted to the Council within 7 days of intimation to the successful bidder. The sale release order/work award shall be issued to the bidder only upon receipt of 100% bid amount.
- c) No goods, materials, equipment shall be allowed to be lifted without receipt of the Sale amount

12. Labour safety: Purchaser shall undertake all safety precautions during the execution of the work. In case of injury to any person Purchaser shall always have arrangement to take him to hospital for treatment at his own cost. Purchaser will be fully responsible for any repercussions which may arise as a result of violation of any safety norms on his part. The Purchaser shall indemnify the Council towards any unwarranted incidents.

13. Other terms and conditions:

- a) The list of obsolete/unserviceable items and its with Style no longer current, indistinct or are imperfect as compared with corresponding part in the related industry to be considered is as per **Annexure-B**. Before submitting bids, the bidders are advised to satisfy themselves by actual visit to the site as regards to quantity and prevailing conditions of the equipment/machinery.

- b) Rates quoted shall be deemed to be inclusive of manpower, material, machinery, tools and tackles, duties, insurance etc.
- c) Any damage done to the existing installation, equipment or to the building particularly due to negligence on the part of the Purchaser or its worker shall be entirely responsibility of the firm to repair, rectify or replace the same free of cost immediately without any delay.
- d) The Purchaser will ensure to lift the materials at a particular site in a single lot.
- e) The bidder will submit only one quotation either himself or as a lead partner in case of partnership firm. No depreciation of cost will be permitted beyond the quoted amount and the purchaser will be bound to lift the materials as per the quoted amount as per the work order.
- f) The bidder is advised to visit and examine the site of works between 11 am to 4 pm on working days at his/their cost and obtain for himself on his own responsibility all information and taken into account all relevant factors pertaining to the work that may be necessary for preparing the quotation.
- g) AEPC reserves the right to reject any or all the quotations without assigning any reason thereof.

14. Annulment of award: Failure of the bidder to comply with the requirement of quotation shall constitute sufficient ground for the annulment of the award in which event quotation shall be cancelled and Council may call for new bids. Any payment thus received including the EMD is liable to be forfeited at the discretion of the Council.

15. Arbitration: In the event of any dispute or difference arising under the contract agreement, the same shall be referred to the sole arbitration of Secretary General, AEPC or any other appointed by him. The award of the arbitrator shall be final and binding on both the parties. The venue of arbitration proceeding shall be at AEPC, Apparel House, Head Office, Gurgaon, Haryana or such place as the arbitrator may decide. The Courts at Haryana only shall have the jurisdiction to decide any dispute that may arise in relation to the contract.
