As per the said notification, all the units engaged in textiles activities, which inter alia includes trader, are required to submit Annual and Monthly returns as applicable to different segment of the textile industry within the stipulated time.

The sole purpose of this exercise by the Textile Commissioner office is to secure crucial inputs for policy making and help designing policies, which are best suited to the changing needs of the Textile Industry. The data submitted by the units shall be used purely for statistical purpose in framing policy measures for the growth and development of the Textile and Clothing industry and confidentiality of the unit level data shall be strictly maintained.

In the wider interest of the entire textile value chain and for the benefit of all the businesses, members are requested to provide Annual and Monthly returns at <u>http://txcindia-stats.gov.in</u> (TSRS portal).
