

Minutes of 36th Meeting of Technical Advisory-Cum-Monitoring Committee (TAMC) for discussing issues of ATUFS and Previous Versions of TUFS at 11:30 am on 21.11.2023 through VC

36th Meeting of the Technical Advisory-cum-Monitoring Committee (TAMC) for discussing the issues on Amended Technology Upgradation Funds Scheme (ATUFS) and Previous Versions of TUFS chaired by Ms. Roop Rashi, Textile Commissioner was held virtually at 11:30 am on 21.11.2023. The list of participants is at **Annexure-I**.

Agenda No.1:

Minutes of 35th meeting of TAMC held on 10.07.2023 were circulated to all the members. As per the comments received from AEPC, an addendum dated 16.08.2023 w.r.t. the agenda point no.8 has been issued and uploaded in the website of this Office. Further, there is no comment / suggestion received for the rest of the agenda from the members of the TAMC. The Minutes including addendum are treated as confirmed.



TAMC was also briefed that a dedicated Camp for settlement of Ahmedabad Region cases was held at Surat from 30.10.2023 to 09.11.2023 as the region has highest pendency owing to highest number of application form this region. The camp was successful and 172 cases were settled in camp with a subsidy value of Rs.25 crore.(Approx.).Besides this Reply for 22 Hqrs level cases complete in all respects was also collected and these cases are being settled at Hqrs level. TAMC was also briefed that such camps shall also be organised in other regions where pendency is high.


TAMC noted the progress under ATUFS and appreciated efforts of the office.

Agenda No.3 & 7: Condoning the delay in timeline to forward the JIT report of the claims under ATUFS in i-TUFS portal beyond 2+7 days.

TAMC was briefed that due to forensic Audit and related patchwork of iTUFS, the access to the iTUFS portal was isolated vide Public Notice 24.01.2023. However, the physical JIT inspection of the claims were carried out to avoid delay in progress of the ATUFS scheme. Since the access to the iTUFS portal has been isolated completely in all the level including field offices and hence the JIT report could not be uploaded for the cases for which Inspections were carried out on or after 24.01.2023. Subsequently, limited access to iTUFS portal was provided through VPN to ease the process of ATUFS claim processing.

Such 516 cases were recommended by TAMC to IMSC for condonation and same have been condoned by IMSC. However, while reconciling the processing of claims it has been observed that, there are **17 more cases** also identified of the similar nature for which JIT report could not be uploaded during the isolation period of iTUFS portal. Besides this **13 cases** were reported by Regional Offices for which the Regional Offices could not submit the JIT report in i-TUFS portal within two days after conducting JIT due to technical issue on i-TUFS portal. ROs have submitted detailed justification and reasons also for the same. During discussion in TAMC, **one more case** of similar nature was pointed out by Chairman of FIASWI. The case was checked and was found to be falling in same bracket. Based on the necessary justification (16 cases for JIT conducted on 23.01.2023, one case left out during listing inadvertently and 14 cases due to technical issue on i-TUFS portal) submitted by the field offices, the **31 cases at Annex-II** were placed before the Committee for necessary recommendation to IMSC for relaxation for uploading of JIT report beyond 2+7 days time line.

Decision of 36th TAMC: -The committee deliberated that since the manufacturing unit was not at fault and process of submission could not be completed in stipulated time frame due to software issue, all above 31 cases which are at Annexure-II are recommended for placing before IMSC for condonation of delay. Committee also suggested that in order to expedite relief to units, the delay may be condoned by MoT at appropriate level which could subsequently be ratified by IMSC as such cases were earlier condoned by IMSC.



Agenda No.4: Condoning the delay in submission of JIT request beyond the timeline of 2 years due to isolation of i-TUFS portal for maintenance /audit purpose.

The iTUFS portal has been kept on isolation for the period of 24.01.2023 to 24.07.2023 vide Public notice dated 24.01.2023. Since the software was not accessible to the Industry, the units could not apply for JIT during that period. After restoration of software for public use, some of units faced initial glitches in submission of JIT request. Since units have to submit JIT request within two years of loan sanction as per operational guidelines of Scheme, the delay in submission of JIT request for such units who could not apply during the period when software was not accessible is required to be condoned. The units can apply for JIT only once the delay is condoned and provisions are enabled in software. The cases for which the cutoff date for submission of JIT request falls between the period of 24.01.2023 and 24.08.2023 has been taken into account taking into consideration the complete restoration of the software resolving the issues faced during resumption of services in portal,

Accordingly 225 cases have been identified from the iTUFS Software and listed in the **Annex-III** and the same may be recommended by the Committee to IMSC for condoning the delay in submission of JIT request beyond the timeline of 2 years from the date of sanction of Term loan.


Decision of 36th TAMC:- The committee deliberated that since the manufacturing unit was not at fault and units could not apply for JIT due to software issue, the relief should be granted to units by condoning the delay. Therefore TAMC recommended 225 cases for placing in IMSC for condoning delay in submission of JIT request beyond 2 years from the date of sanction of Term loan. TAMC also suggested that in order to expedite relief to units, the delay may be condoned by MoT at appropriate level which could subsequently be ratified by IMSC.

Agenda No. 5: Treatment of claims where over invoicing have been occurred.

The matter with respect to wide variation in price of machines having same model no /specifications, purchased contemporaneously from same manufacturer was discussed in the 19th TAMC meeting additional agenda point no.6 and it has been decided to forward those cases / claims where more than 50% variation in invoice of the machinery of same manufacturer with same specifications to Department of Revenue Intelligence for further investigation.

There are few cases on the above said matter has been identified and those claims were rejected and marked as "Not recommended" in the i-TUFS portal. Subsequently the matters are being taken up with the concern lending agencies who have sanctioned the term loan under ATUFS claims for taking up with DRI for further investigation.

This is for information of TAMC.



Discussion and Decision of 36th TAMC:- Some of Industry representatives pointed out that Industry should be given chance to explain the reasons for over invoicing. The committee was informed that unit has made detailed presentation before ITC(Internal Technical Committee) more than once and after due diligence the case was referred to DRI. TAMC noted the development in this regard.

Agenda No.6: Shifting of machineries claimed under ATUFS after conduct of JIT inspection without prior intimation to the Office of the Textile Commissioner.


As per the Para no.3.10 of the Revised Resolution under ATUFS dated 02.08.2018, “Except in case of merger, acquisition, amalgamation or takeover of the entity, the plant & machinery purchased with the subsidy under TUFS shall not be disposed off before 10 years of date of purchase without prior approval of The Textile Commissioner.”

Accordingly, the units are submitting the declaration confirming the compliance of the above said para during JIT inspection. However, it is identified while conducting super check of the unit for which JIT have already been conducted that, few units have shifted / disposed the claimed machineries before 10 years from the date of purchase without prior approval of the Textile Commissioner. Such cases are not being considered for the release of subsidy under ATUFS for their claim and further explanation is being sought from the concern units who are misleading GOI by claiming undue subsidy. In case of the units failed to submit the justification for such activities, the entity may be blacklisted for availing any benefits under the schemes implemented by the Office of the Textile Commissioner, Ministry of Textiles, Govt. of India.

Further, the TAMC in its 20th meeting Agenda point no.4 requested the lending agencies to submit the list of cases which are disposed off / shifted the machineries purchased under the Term loan sanctioned under ATUFS (after the JIT inspection) to the Office of the Textile Commissioner periodically. However, there are no such lists have been provided by any lending agencies so for.

The Committee may take note of above and Industry Associations may sensitize the Industry about consequences of such wrong practices.

Discussion and Decision of 36th TAMC:- Some members of TAMC were of the opinion that 10 years period for disposal should be reduced to 7 yrs due to fast developments in technology. The TAMC was briefed that Scheme is already closed and it may not be feasible to change it at this stage, However guidelines stipulate that prior approval has to be taken from the Textile Commissioner before disposal. Regarding shifting of unit , it was discussed that if it is before JIT then unit is allowed to carry out one time correction in address. However, if unit shifts after JIT, the unit should intimate to the Textile Commissioner.



TAMC suggested that a circular/public notice in this regard may be issued for general awareness of the Industry.

Agenda No.8: For ratification of machinery manufacturer/authorized agents enlistment

Enlistment of 3 machinery manufacturer/authorized agents as per **Annexure-IV** recommended by Internal Technical Committee (ITC) in its 69th meeting dated 13.07.2023 & 70st meeting dated 27.07.2023 is placed before the TAMC for ratification

The committee may review and ratify the decision

Decision of 36th TAMC:- TAMC ratified the decision of 69th & 70th ITC.

Agenda No.9: (Agenda Point No. 3. of 69th ITC):

Physical verification of machinery manufacturer M/s. Nex Yarn Technology LLP for enlistment under ATUFS.

The machinery manufacturer resubmitted their enlistment request in reference to the ITC decision of 64th ITC dated 13.04.2023 discussed through VC Mode which is reproduced below. "Not recommended as the unit is not manufacturing machines of benchmark technology".

The unit requested for physical verification to ascertain the technology machines manufactured in their manufacturing plant and visit to the machines running at ATUFS beneficiary units. In addition to that, they requested for in person meeting with the committee for discussion in this regard.

Decision Taken in 66th ITC dated 25.05.2023: In view of the submission made by the unit, the committee decided that a team from Headquarters consisting of one Assistant Director (Technical), One officer from RO-Ahmedabad and one Technical Officer from HQ will visit the unit and submit the inspection report verifying the capacity or otherwise of the unit to manufacture the benchmarked technology machines as per ATUFS Scheme.


With the approval of competent authority, Shri Humayun Assistant Director (Technical) and Shri Kislav (Technical Officer) from Head Quarter along with Technical officer Shri Ghanshyam Sharma from Regional Office-Ahmedabad visited the manufacturing unit on 11.07.2023.

Recommendation of the team: The team opined that the unit is not having sufficient infrastructure and no allied manufacturing facilities such as standard manufacturing processes, R&D/testing facilities, and inventory/finished goods management within the manufacturing infrastructure. The team recommends not to consider the unit for enlistment under ATUFS for sizing and warping machines.

Decision taken in 69th ITC: The committee reviewed the physical verification report and noted that the unit is not having sufficient manufacturing infrastructure/activity. Hence, the committee not recommended the enlistment of M/s. Nex Yarn Technology LLP as textile machine manufacturer under ATUFS.

The committee may deliberate and ratify the decision

Decision of 36th TAMC:- TAMC ratified the decision of 69th ITC



Agenda No.10: (Agenda Point No. 2. of 71st ITC): Request for Change of Effective date in respect of previous request for starting commercial activities from one unit to another unit as per previous ITC decision

M/s. Monforts Fong's Textile Machinery (Zhongshan) Co. Ltd vide letter dated 21.09.2021 through M/s.ATE Enterprises Private limited has informed that M/s. Monforts Fong's Textile Machinery (Macao Commercial Offshore) Co. Ltd. who was doing the commercial activities for M/s. Monforts Fong's Textile Machinery (Zhongshan) Co. Ltd is shifted their commercial activities to M/s. Monforts Fong's Textile Machinery Co. Ltd, Hongkong with effect from 22.02.2021.

In this connection, M/s. Monforts Fong's Textile Machinery (Zhongshan) Co. Ltd submitted self-declaration in their letterhead and consolidated financial statement 2020 (Annual report) of M/s. Monforts Fong's Textile Machinery Co. Ltd, Hongkong.

Decision Taken in 36th ITC dated 10.02.2022: The committee gone through the documents and after detailed discussion, the committee recommended the case to consider change the commercial activities office from Macau to Hong Kong w.e.f. 22.02.2021.

Decision Taken by 27th TAMC dated 13.04.2022: The committee reviewed the case and accepted the recommendations of the ITC.

M/s.ATE Enterprises Private Limited vide email dated 20.06.2022 requested to change the effective date from 22.02.2021 to 31.05.2021 and mentioned due to oversight the manufacturer mentioned date wrongly.

In this regard, they submitted below documents:

Decision taken in 46th ITC dated 19.07.2022: The committee reviewed the matter and decided to call for legal/ government documents in support of their request.

In reference to the decision, the unit submitted below documents vide email dated 27.07.2023 and 07.08.2023,






