#### REIMBURSEMENT OF AIRFARE (ECONOMY CLASS)

**Eligibility for financial assistance under Market Access Initiative (MAI) scheme:** As per Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for availing MAI grant with following conditions:

- As per MAI Guidelines, Partner/Director/Proprietor/Regular Officer on Senior Managerial Position of participating firm/company (with exports FOB value between Rs.50 lakhs to Rs. 50 Crores in preceding financial year) is eligible for reimbursement of actual airfare (Economy Class) upto a maximum ceiling of Rs.90,000/-. Non-MAI Exhibitor shall not be eligible for reimbursement.
- Participating companies must have completed 12 months of membership with EPC/FIEO.
- As per MAI guidelines, a company/firm can avail subsidy for maximum three MAI events in the same financial year either from FIEO/any EPC/grantee organizations and upto a maximum of three times (including past cases) for a particular event thereafter have to participate in that fair on their own.
- Claim forms duly filled and complete in all respects must be submitted to the AEPC within 45 days of return to India.

#### **REGISTRATION PROCESS:**

Members are encouraged to take advantage of this exceptional opportunity to showcase their products and explore new business prospects in the Japanese market. To confirm your participation, please transfer **participation charges** and submit the completed Registration Form along with payment confirmation **by 21**<sup>st</sup> October (Monday), 2024. Please note that booth allocation will be done on a "First Come, First Serve" basis upon receipt of the participation fees.
