Participation in "International Apparel and Textile Fair" in Dubai, UAE (From 20th to 22nd May, 2025)

Dear Member,

AEPC is participating in "International Apparel and Textile Fair", Dubai, UAE to be held from 20th to 22nd May, 2025, which will take place at Dubai Festival Arena, Intercontinental Dubai, UAE.

1. About IATF:

International Apparel and Textile Fair (IATF) is UAE's premier platform for sourcing Apparel, Fashion Fabrics, Prints, Machineries, Clothing Accessories, Home Textiles, Footwear and Handbags. IATF in its 19th edition will be showcasing Spring-Summer collections & Autumn-Winter highlights. The fair attracts a wide range of textile mills, accessories / trim suppliers, print designers, and major footwear manufacturers. Exhibitors are mainly from China, Egypt, Turkey, Poland, France, Korea, Spain, Germany, Japan, Belarus, Hong Kong, Malaysia, Sri Lanka, Indonesia, India & many more highly renowned manufacturing countries across the globe.

2. Why you should exhibit in IATF, Dubai?

India is one of the largest trade partner for the United Arab Emirates (UAE) and the second largest supplier to UAE after China. The India-UAE Comprehensive Economic Partnership Agreement (CEPA) is estimated to take bilateral trade between India and UAE to a new level. Apparel imports into Dubai have been increasing in the last five years. UAE's imports of RMG from the world was 4438.9 USD Million in 2019 which increased to 6606.7 USD Million in 2023. Indian export of RMG to UAE has also been stable with India capturing a share of 15.00% in UAE's total apparel import in 2023.

Accounting for about 5.5 percent of the world's annual textile and clothing sales, the UAE has today become the world's fourth largest trading center of fashion and apparel.

IATF provides manufacturers and their agents an opportunity to showcase their products to the most influential buyers and designers in the Middle East & North Africa (MENA) Fashion sphere. Principally a "Trade Only" event, IATF provides a professional and conducive atmosphere for business and networking.

5. Eligibility for financial assistance under Market Access Initiative (MAI) scheme:

The Apparel Export Promotion Council has submitted a proposal to the concerned Ministry, requesting the MAI Grant for participation in the 19th Edition of International Apparel and Textile Fair (IATF). The Ministry's decision on our proposal is awaited and cannot be considered approved unless confirmed in writing.

The MAI Grants as and when received will be disbursed to the eligible exhibitors as per MAI Norms.

It is pertinent to mention that as per Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for availing MAI grant with following conditions:

"a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be provided to a member for a maximum of three MAI events in a year. In case of exporter belonging to SC/ST/Women and the exporter is having FOB Value of exports less than Rs. 50 crore in a year, 5 participations in a particular event is allowed."

Reimbursement of airfare: - Further, the Council would propose to Dept. of Commerce for sanction of grant on account of reimbursement of airfare (economy class) if it is approved by Ministry of Commerce, Govt. of India. accordingly, regular Director / Partner / Proprietor / regular officer of the company on senior managerial position of participating firm/company presently having a minimum of 12 months continuous membership with Council, exporter having minimum FOB value of exports Rs. 50 Lakhs but below Rs. 50 Cr. in the preceding financial year shall be eligible for reimbursement of airfare as per MAI Guidelines under para 6 (ii) of the Market Access Initiative Scheme 2021 issued by the Ministry of Commerce from time to time. Non-MAI Exhibitor shall not be eligible for reimbursement.

(On receipt of MAI grant from the Ministry, the booth cost will be subsidized and accordingly the amount so decided would be refunded to the eligible exporters as per MAI norms)

9. Guidelines for allotment of the booths:

- i) All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lots by AEPC.
- ii) No change in the booths, once allotted would be entertained under any circumstances.
- iii) The decision of Chairman-EP (AEPC) / Chairman (AEPC) would be final and binding in case of any dispute.
- iv) The participation is on **FIRST-CUM-FIRST SERVED (FCFS)** till all booths are sold and the allotment of stalls shall be done through draw of lot basis.

10. Waitlist:

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess will obtain necessary visa to enter UAE. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

11. Cancellation charges:

Terms & conditions for withdrawal will be as follows:

- Rs. 25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.
- 100% forfeiture after Draw of Lot.
