Participation in “Texworld- Apparel Sourcing-Paris-France
(From 1-3 July, 2024)

Dear Member,

AEPC is participating in “Texworld- Apparel Sourcing-Paris-France to be held from 1st July to 3rd July, 2024, which will take place in Porte De Versailles, Hall 7, Paris, France.

1. About Texworld- Apparel Sourcing-Paris-France:

Texworld 2024 Paris will offer a wide range of Ready to wear (Menswear, Women’s wear, Children'swear and Fashion Accessories), Textiles, and Trims, About 1500 exhibitors from across the world will be present at the Texworld Expo 2024. The show - Complete Chain from Yarn to Fabrics, Cotton & blends, Eco friendly Fabrics, Drapery, Embroidery & Lace, Fibers, Functional & Sportswear, Jacquard, Knitted fabrics, Linen & Hemp, Prints, Shirting, Silk, Silky aspects, Style Trims & Accessories, Wool & Wool Aspect.

Texworld Paris has the vast buyers profiles - Ready-to-wear brands, top range fashion brand, fast retail, bridal, evening, independent designers, Buying offices, Clothing and Accessories brands, Garment Retailers and Wholesalers, Mail-order, Large-scale retailing, Chain Stores, Department Stores.

Apparel imports into France have been increasing in the last five years. France import from the world was 24255.24 USD Million in 2021 which increased to 26853.18 USD Million in 2022. Indian export of RMG to France has also been stable with India capturing a share of 4.44% in 2022.

5. Avail benefit in participation fee on account of MAI grant from Ministry of Commerce:

NOTE: The proposal has been submitted to the Ministry of Commerce, Govt. of India for MAI Grant and following is subject to the receipt of approval / sanction of Grant.

6. Eligibility for financial assistance under Market Access Initiative (MAI) scheme:

Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for MAI grant has following conditions:

“a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be provided to a member for a maximum of three MAI events in a year. In case of exporter belonging to SC/ST/Women category and having FOB Value of exports less than Rs. 50 crore in a year, 5 participations in a particular event is allowed.”

Reimbursement of airfare: - Further, the Council would propose to Dept. of Commerce for sanction of grant on account of reimbursement of airfare (economy class) if it is approved by Ministry of Commerce, Govt. of India. Accordingly, regular Director / Partner / Proprietor / regular officer of the company on senior managerial position of participating firm/company having 12 months membership with Council, exporter having minimum FOB value of exports Rs. 50 Lakhs but below Rs. 50 Cr. in the preceding financial year shall be eligible for reimbursement of airfare as per MAI Guidelines under para 6 (ii) of the Market Access Initiative Scheme 2021 and its amendment in 2023 issued by the Ministry of Commerce.

Non-MAI Exhibitor shall not be eligible for reimbursement.

7. **Participation Charges:** The participation charges do not include air-fare, hotel expenditure or any other kind of personal expenses (logistics etc.). The below subsidized participation fee is based on the anticipated grant from the Ministry. In case of any variation the participation fee may be revised.

Participation charges without MAI Grant (The applicants, who fail to make full payment of participation charges, will not be considered for allotment of booth)	Rs. 6,80,000/-

Rush to book your booth by making the payment of participation charges ASAP.

8. The last date for submission of application with payment is 15th May, 2024.

9. Booth Package :

The following booth facilities shall be provided to the participating exhibitors :

Table, Chairs, Wastepaper Basket, Insurance, Standing cleaning, Partition Walls, Rods, or Shelves Electrical outlets, Lighting, Booth Signage, Visitor Promotion Banner, Promotional Network Services.

11. Guidelines For Allotment of The Booths:

1. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot.
2. No change in the booths, once allotted would be entertained under any circumstances.
3. In case of default of any payment due from the participants, AEPC reserves the right to debar them from participation in AEPC's International fairs and bring to the notice of appropriate authority.
4. The participation is on **FIRST-COME-FIRST SERVED (FCFS)** basis till all booths are sold and the allotment of stalls shall be done through draw of lot.

12. Waitlist:

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess necessary visa to enter France. No request for refund will be entertained by AEPC if visa is not granted for any reason.

13. Cancellation charges:

Terms & conditions for withdrawal will be as follows:

- Rs. 25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.
- 100% forfeiture after Draw of Lot.

10. Participants will be required to furnish complete information on orders booked, enquiries generated etc., in the form of Feedback form after the fair which is required by the Ministry as you are entitled for the grant/subsidy.
11. In case of default of any payment due from the participants, AEPC reserves the right to debar them from participation in AEPC's International fairs and bring to the notice of appropriate authority.
