**4. Avail benefit in participation fee on account of MAI grant from Ministry of Commerce:**

**NOTE: The proposal has been submitted to the Ministry of Commerce, Govt. of India for MAI Grant and following is subject to the receipt of approval / sanction of Grant.**

**Eligibility for financial assistance under Market Access Initiative (MAI) scheme:** Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for MAI grant has following conditions:

“a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be provided to a member for a maximum of three MAI events in a year. In case of exporter belonging to SC/ST/Women category and having FOB Value of exports less than Rs. 50 crore in a year, 5 participations in a particular event is allowed.”

**5. Participation Charges:** *The participation charges does not include air-fare, hotel expenditure or any other kind of personal expenses (logistics etc.).*

## 7. Booth Packages:

The following booth facilities shall be provided to the participating exhibitors.

- 2.5 m high panels, fascia board, Carpet, 1 Table, 3 Chairs, 3 hanger rods (garment booth) OR 3 shelves (for accessory booth) and 1 triple socket.

## 8. Guidelines for allotment of the booths:

1. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot.
2. No change in the booths, once allotted would be entertained under any circumstances.
3. In case of default of any payment due from the participants, AEPC reserves the right to debar them from participation in AEPC's International fairs and bring to the notice of appropriate authority.
4. The participation is on **FIRST-COME-FIRST SERVED (FCFS)** till all booths are sold and the allotment of stalls shall be done through draw of lot.

## 9. Waitlist:

In case applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess to necessary visa to enter Saudi Arabia. No request for refund will be entertained by AEPC if visa is not granted for any reason.

## 10. Cancellation charges:

Terms & conditions for withdrawal will be as follows:

- Rs. 25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.
- 100% forfeiture after Draw of Lot.
