Subject: Scrutinizer's Report on EGM of Apparel Export Promotion Council held on 01<sup>st</sup> Day of March 2024, Friday, through Video Conferencing, pursuant to the provisions of section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 21 of the Companies (Management and Administration) Amendment Rules, 2015.

I, Arya Kumar Das, Under Secretary, Govt. of India has been appointed as a Scrutinizer for the purpose of scrutinizing the election of the Executive Committee Member in a fair and transparent manner and ascertaining the requisite majority at the Extraordinary General Meeting of the Council held on 01st March, 2024 through Video Conferencing/Other Audio Video Means.

Department of Commerce, Ministry of Commerce & Industry, Government of India vide letter No 12/1/2017-E&MDA dated 10.05.2023 read with OM dated 27.06.2023 had put on hold the election process of the office bearers of the EPC till the issue of new guidelines and had also informed to maintain status-quo. Accordingly the 280th Executive Committee of the Council in its Meeting held on 23.11.2023 through Video Conferencing decided to hold 44th Annual General Meeting on 27.12.2023 (Wednesday) at 11.00 A.M through Video Conferencing/Other Audio Video means, without retiring the members who are liable to retire at the AGM and without holding election of the Executive Committee Members.

The Department of Commerce vide communication dated 22.12.2023 circulated the final Article of Association/Bye-laws for adoption by EPCs/FIEO with an instruction to hold the election as per the model bye-laws only.

The Executive Committee of the Council in its meeting held on 23.01.2024 decided to hold Extra Ordinary General Meeting of the Council on 01st March, 2024 (Friday) at 12:00 Noon through Video Conferencing to conduct the election of the Executive Committee Members, who were liable to retire at the 44th AGM held on 27.12.2023, as per the new Model Article of Association/Bye-Laws. The committee also decided to increase the composition of the Executive Committee from current 28 Elected Members (9 members each from western, Northern and Southern Region and one member from Eastern Region) to 33 elected member's i.e including 5 seats be kept reserved for the following categories:

- i) Women entrepreneurs- (2 seats reserved)
- ii) Start-ups (1 seats reserved)
- iii) Young entrepreneurs (1 seats reserved)

## iv) North Eastern/Hill Regions (1seats reserved)
